

The MSA Program, a stand-alone graduate program, is designed not just to be exam preparation but career preparation. The program provides students with the courses required to qualify for the Certified Public Accountancy (CPA) license while gaining a graduate degree from the prestigious Cox School of Business. While at Cox, students are exposed to valuable networking opportunities and taught by distinguished faculty in a small-classroom setting.

The MSA can be pursued either full time or part time. If taken full time, the MSA can be completed in two semesters. If taken part time, the MSA can be completed in four semesters. The MSA requires a total of 32 credit hours.

Application Requirements

Students are admitted to the MSA for the fall or spring term. Applicants are required to submit the following items for admission consideration:

- Application Form & Application Fee
- Cover Letter & Resume
- Essays
- Official GMAT Score Report (not required for SMU Cox undergraduates)
- Transcripts from all colleges and universities attended
- Recommendations
- Official TOEFL or Pearson PTE Score Report (International only)

Prerequisite Requirements

Applicants must demonstrate proficiencies in the following areas as demonstrated by satisfactory completion of the following courses, or course equivalents:

Fundamentals of Accounting (I & II)	6 credit hours
Intermediate Accounting (I & II)	6 credit hours
Federal Income Tax	3 credit hours
Cost Accounting	3 credit hours

Please note that Cost Accounting can be fulfilled by completing ACCT 6205 as an elective during MSA. The other courses must be completed **PRIOR** to beginning the Cox MSA program. These courses do not have to be completed at SMU, but it is preferred that they be completed at a four-year accredited university.

All of the required accounting courses and accounting electives are offered during the day and night (subject to availability). Some electives may only be available either day or night. Estimated tuition and general student fees for part-time enrollment during the 2009-2010 academic year is \$1,487 per credit hour.
